4. Entry Forms - Entries

4.1 Anybody wishing to take part in the Competition must send the attached entry form duly completed to the Secretariat (address see above) until the 15th June 2020.

4.2 The maximum number of participants is 100 vehicles with maximum 20 Heat in one qualification. CEZ, MČR, MSR, ČTHA - limit 80 vehicles, Mascom Cup - 20 vehicles. In case of less interest the limit in the cups may change.

5. The Entry Fees

5.1 The entry fee (insurance included and services) - 1st closing date of entries - is according to the tariff in the registration form and according to the version of the race which will be announced by the organizer according to the registered drivers. The deposit must be paid by bank transfer no later than 3 days after the deadline for applications with a normal deposit.

Entry fee has to be paid in closing date of entries latest.

The foreign drivers can pay the entry fee during the administrative checking, must be logged in, otherwise point 5.2 applies.

5.2 The participants applied after the first closing date of the entries will pay 50 € more.

5.3 A competitor may be charged an additional deposit of € 75 if he refuses to bear the sponsor's name.

5.4. Entry fees may be refunded only:

- to candidates who are not accepted
- in the case of the Competition not taking place
- if the Competitor withdraws his entry no later 22. 6. 2020
- If the withdrawal is announced to the organiser between that Monday and the opening of the administrative checking, 50 % of the entry fee will be refunded.

6. Insurance

6.1 Insurance coverage of the organiser

The Autoklub CR concluded with " Allianz pojišťovna, a. s " , through the company PLATINUM Consulting s.r.o., the frame insurance contract No. 400046134 on insurance of liability of the organiser for damage caused to the others in connection with a sport enterprise up to the sum of CZK 10.000.000.

6.2 Insurance of competitors and drivers

The part of the frame insurance contract No. 400046134 is insurance of cars of the participants against damages caused to third persons up to the sum of CZK 10.000.000 per one insurance event with co-participation of CZK 5.000. Any damage below CZK 5.000 will be paid by the driver who caused the damage; damages above CZK 5.000 will be paid by the insurance company without any co-participation of the insured. However the insurance does not cover liability for the damages caused by event participant that the competitors cause each other in the course of sport event.

6.3 Each driver is obliged to conclude his personal injury insurance and to present a proof on request the administrative checking. The insurance of foreign drivers must include coverage of costs for possible medical treatment in the CR.

IV. CHECKINGS

7. Administrative Checking

Every driver (or his / her representative) has to attend the administrative checking, taking place: **on Friday, the 26th of June, 2020 from 17:00 – 20:00 and on Saturday 9:30 – 12:30 in TBA.**

8. Technical Scrutineering

8.1 Every vehicle has to attend the scrutineering, taking place on **on Saturday 9:30 – 12:30 in TBA.**

8.2 For all cars, a limit of 100 dB is imposed.

V. RUNNING OF THE COMPETITION

9. Practice and Information for drivers

9.1 The free practice session is 4 laps. Every driver must participate in at least one free practice session. Every driver must finish minimum one lap of the practice session. Otherwise his/her start in the first qualifying heat must be decided by the Stewards. The Joker lap can be used during the free practice session.

9.2. The Kartcross division will run 2 official measured practice sessions, the first one according the starting numbers while the second one in the reverse order.

10. Qualifying

There will be 4 laps in the qualifying heats. The Kartcross division does not take the Joker lap. The car must be in the pre-start area five minutes before.

11. Semi-finals and Finals

11.1 Semi-finals will be 5 laps - CEZ+MČR+MSR+ČTHA+KC.

11.2 Finals will be 6 laps - CEZ+MČR+MSR+ČTHA+KC.

12. Flag signals

If the black flag or the black flag with the orange target is shown in a heat, the driver has to go immediately to the paddock. If the same situation happens in the final heat, the driver has to go to the Parc Ferme.

VI. PROTEST – RESULTS – PARC FERME

13. Protest - appeal

13.1 All protests are accepted and resolved in accordance with the paragraph 5.2 of the Disciplinary Code of the ACCR. All protests must be made in writing and handed to the clerk of the course or his assistant, or in their absence any of the stewards, together with the sum of 11 500 CZK, in cash. The claimant must make a deposit of 250 000 CZK, If the protest requires any dismantling and re-assembly of different parts of a car.

13.2 Competitors have the right to appeal, as laid down in the paragraph 5.3 of the Disciplinary Code of the ACCR. The fee is 22 000 CZK.

13.3. Results

All the results will be posted 10 minutes after every qualifying and final heat on the official notice board in the parking area.

13.4. Parc Ferme

The Parc Ferme is located in the central part of the circuit. There is no Parc Ferme for the ČTHA and Kartcross divisions.

VII. PRIZES AND CUPS

14 Prizes

The podium ceremony - CEZ+MČR+MSR+ČTHV+KC will be held on Sunday, the 28th of June 2020 before Headquarters. The winners of the 1st, 2nd and 3rd prizes will follow an instruction of the marshals. Failure to attend this ceremony will be penalized by the loss of any monetary award / benefit associated with the corresponding position at the end of the race.

VIII. FURTHER INFORMATION

15. Fire extinguishers

Each driver is responsible to make sure there is a single piece of extinguisher of min. 5 kg available within his own team's area inside the paddock.

16. Protection of the environment

Each driver is obliged to keep a plastic sheet (minimum dimensions 4 x 5 meters) on the ground, under the vehicle, in the place where work on his/her car is done, in order to prevent any soil pollution in case of an accidental leak of oils or petrol, etc.

17. The Drivers' Liaison

The Drivers' Liaison Officer will be recognisable by orange vest, with his phone number and the sign Drivers' Liaison Officer written on it. His photo can be found on the official notice board. He can be reached Directorate of the Race.

18. Authorisation

These Regulations have been agreed by ACCR on **1st June 2020**, Visa No. **RX00220**.

Appendix 1

a) After the arrival to the Autodrom v Sosnová, every registered driver will be provided with 1+3 pieces of the identification bands with a digit code for later identification. Other bands if needed can be bought on the spot for 250 CZK (10 €) for a piece. All the participants of the race are required to wear the identification bands on the arm during the whole weekend. The bands must be shown when requested by the fee collector or by the organizer of the race. If a person is caught without the band, he/ she must buy one band or will be expelled out of the racing complex.

b) The speed limit in the area is 30 kms/h.

c) Silent hours 24.00 p.m. - 6.00 a.m.

d) The parking space will be divided according to the instructions of the car park manager based on the application form.
