1. In general

1.1 AUCTOR Racing s.r.o. organizes the FIA Central European Zone Rallycross Championship (FIA CEZ Championship), Championship of Czech Republic in Rallycross (MČR), Championship of Poland (MPRC), Championship of Austrian (MA), Championship of Slovak Republic (MSR), the Czech Trophy for The Historic Cars (ČTHA), the Mascom Cup 2021 (KC), in accordance with the international Sporting Code of the FIA (and its appendices), the national regulations, these regulations and their provisions and its appendices.

Measures related to the occurrence of COVID-19 virus

Competitors, riders, their companions, officials, organizers and other staff are required to comply with a set of hygiene measures in accordance with current regulations of the Ministry of Health. The numbers of persons present and the organization of the service area will correspond to a set of hygienic and epidemiological measures according to the currently valid regulations. These measures and restrictions will be issued in the form of implementing provisions at least one week before the event.

3. **Entry Forms - Entries**

3.1 Anybody wishing to take part in the Competition must send the attached entry form duly completed to the Secretariat (address see above) until the 13th June 2021.

3.2 The maximum number of participants will be determined according to the valid for the given period. However, no more than 200 drivers across all the announced championships and cups. In case of filling the capacity.

4. The Entry Fees

a) 1st closing date of entries – 182 €uro for CEZ, MČR, MPRC, MSR, MA, 151 €uro for RWD CUP, 114 €uro vor ČTHV, Mascom CUP, SC CUP. Entry fee has to be paid in closing date of entries latest.

2st closing date of entries - Entry fee has to be paid in closing date of entries latest.

For paying from abroad - Foreign drivers - account in EURO

When paying from an account that is not in EURO, enter the payment in EURO, otherwise a fee will be paid 4 Euro from the payment.

Furthermore, a fee for insurance and services will be collected during the administrative acceptance. The insurance fee for the CEZ, MČR, MPRC, MSR, MR championships is 18 €, for the ČTHA, Mascom Cup and SC Cup cups is 15 €. The service fee is 19 €.

b) The participants applied after the first closing date of the entries will pay 50 € more.

4.3 A competitor may be charged an additional deposit of € 75 if he refuses to bear the sponsor's name.

5.4. Entry fees may be refunded only:

- to candidates who are not accepted
- in the case of the Competition not taking place
- if the Competitor withdraws his entry no later 21. 6. 2021
- If the withdrawal is announced to the organiser between that Monday and the opening of the administrative checking, 50% only of the entry fee will be refunded.

5. Insurance

5.1 Insurance coverage of the organiser

The Autoklub CR concluded with "Allianz pojišťovna, a.s." , through the company PLATINUM Consulting s.r.o., the frame insurance contract No. 400046134 on insurance of liability of the organiser for damage caused to the others in connection with a sport enterprise up to the sum of CZK 10.000.000.

5.2 Insurance of competitors and drivers

The part of the frame insurance contract No. 400046134 is insurance of cars of the participants against damages caused to third persons up to the sum of CZK 10.000.000 per one insurance event with co-participation of CZK 5.000. Any damage below CZK 5.000 will be paid by the driver who caused the damage; damages above CZK 5.000 will be paid by the insurance company without any co-participation of the insured. However, the insurance does not cover liability for the damages caused by event participant that the competitors cause each other in the course of sport event.

5.3 Each driver is obliged to conclude his personal injury insurance and to present a proof on request the administrative checking. The insurance of foreign drivers must include coverage of costs for possible medical treatment in the CR.

6. Administrative Checking

Every driver (or his / her representative) has to attend the administrative checking, taking place: **on Friday – 25. 6. – 19.00 – 21.00 o'clock, on Saturday 7:30 – 12:30 o'clock in TBA.**

7. Technical Scrutineering

7.1 Every vehicle has to attend the scrutineering, taking place **on Friday – 25. 6. – 19.00 – 21.00 o'clock, on Saturday 26. 6. 7:30 – 12:30 o'clock in TBA.**

7.2 For all cars, a limit of 100 dB is imposed.

8. Practice and Information for drivers

8.1 The free practice session is 4 laps. Every driver must participate in at least one free practice session. Every driver must finish minimum one lap of the practice session. Otherwise, his/her start in the first qualifying heat must be decided by the Stewards. The Joker lap can be used during the free practice session.

8.2. The Kartcross division will run 2 official measured practice sessions, the first one according the starting numbers while the second one in the reverse order.

9. Qualifying

There will be 4 laps in the qualifying heats. The Kartcross division does not take the Joker lap. The car must be in the pre-start area five minutes before.

10. Semi-finals and Finals

10.1 Semi-finals will be 6 laps

10.2 Finals will be 6 laps

11. Flag signals

If the black flag or the black flag with the orange target is shown in a heat, the driver has to go immediately to the paddock. If the same situation happens in the final heat, the driver has to go to the Parc Ferme.

12. Protest - appeal

12.1 All protests are accepted and resolved in accordance with the paragraph 5.2 of the Disciplinary Code of the ACCR. All protests must be made in writing and handed to the clerk of the course or his assistant, or in their absence any of the stewards, together with the sum of 11 500 CZK, in cash. The claimant must make a deposit of 250 000 CZK, if the protest requires any dismantling and re-assembly of different parts of a car.

12.2 Competitors have the right to appeal, as laid down in the paragraph 5.3 of the Disciplinary Code of the ACCR. The fee is 22 000 CZK.

12.3. Parc Ferme

The Parc Ferme is located in the central part of the circuit. There is no Parc Ferme for the ČTHA and Kartcross divisions.

12.4. Results

All the results will be posted 10 minutes after every qualifying and final heat on the official notice board in the parking area.

13. Prizes

The podium ceremony will be held before Directorate of the Race. The winners of the 1st, 2nd and 3rd prizes will follow an instruction of the marshals. Failure to attend this ceremony will be penalized by the loss of any monetary award / benefit associated with the corresponding position at the end of the race.

14. The Drivers' Liaison

Appendix 1

- a) After the arrival to the Autodrom v Sosnová, every registered driver will be provided with 1+3 pieces of the identification bands with a digit code for later identification. Other bands if needed can be bought on the spot for 200 CZK (10 €) for a piece. All the participants of the race are required to wear the identification bands on the arm during the whole weekend. The bands must be shown when requested by the fee collector or by the organizer of the race. If a person is caught without the band, he/ she must buy one band or will be expelled out of the racing complex.
- b) in the area is limited to 30 km/h.
- c) Silent hours 24.00 p.m. - 6.00 a.m.
- d) The parking space will be divided according to the instructions of the car park manager based on the application form.
- e) Each driver is responsible to make sure there is a single piece of extinguisher of min. 5 kg available within his own team's area inside the paddock.
- f) Each driver is obliged to keep a plastic sheet (minimum dimensions 4 x 5 meters) on the ground, under the vehicle, in the place where work on his/her car is done, in order to prevent any soil pollution in case of an accidental leak of oils or petrol, etc.
